All merchandise must be removed by 8 pm, unless prior arrangements have been made.
- DEADLINE:** All applications must be submitted by 14 February 2018.

- VENDOR SPACE:** Booth space is limited to a plot 20' x 30'. Multiple plots may be reserved. Come prepared for all types of weather. You must secure your booth in case of windy conditions. The plot will be 30' wide facing primary walk path, and the space will be 20' deep.
- ELECTRICITY:** Vendors must list all electrical connections on application. Electrical arrangements must be made prior to your arrival. Last minute electrical changes will not be accepted. (ALL GENERATORS MUST BE APPROVED BY SEAHG)
- SALES:** All items being sold or displayed **MUST** be contained in the booth space purchased. No items, solicitation, or set-up shall take place outside the purchased booth space. Sales tax of 9% must be collected and reported by the vendor, not SEAHG.
- WEATHER:** This is an outdoor event; be prepared for any type of weather. Tents, canopies and pop-ups must be secured to withstand the weather. There is no rain date as a contingency. The event will occur rain or shine, barring weather of a dangerous nature.
- CERTIFICATE OF INSURANCE:** A current Certificate of Insurance is not required, but is suggested, for all vendors.
- BUSINESS LICENSE:** A current City of Dothan business license is required. If you do not have one, one can be obtained from the city, or you may choose to be covered by the event business license. Please note, sales tax of 9% must be collected and reported by the vendor, not SEAHG.
- REQUIREMENTS:** The exhibitor will be responsible to be open during the entire festival. You cannot vacate early. Your booth must be neat, attractive and well-maintained. Signage with visible and clear pricing is required. You are responsible for setting up, maintaining, and removing your own booth, your merchandise and your trash.
